



2024 BICSI Cabling Skills Challenge Application

The 2024 BICSI Cabling Skills Challenge will take place 29-31 January at the 2024 BICSI Winter Conference & Exhibition (28 January - 1 February) in Orlando, Florida. All BICSI-credentialed Installers and Technicians are invited to submit an application. Competitors will be selected based on qualifying criteria such as professionalism, quality of resume, and work experience. An attempt will be made to equally represent all regions and districts.

In order to participate, the BICSI INST1®, INST2®, INSTC®, INSTF®, or TECH™ must secure approval from their employer. The contestant, their employer, or sponsor(s) will be responsible for all travel costs, including transportation to and from the competition, meals, and accommodations. All competitors will receive a full complimentary conference registration, sponsored by BICSI. Past judges are not eligible to participate. Companies are encouraged to submit multiple applications. No more than one application will be selected per level, per company.

Each applicant must have a current BICSI INST1, INST2, INSTC, INSTF, or TECH certification at the time of application and, if selected as a competitor, at the time of the competition. An exception will be made for applicants that live in a district that does not have reasonable access to a BICSI ATF as long as they compete in a local BICSI sanction district CSC event.

Each competitor is required to provide their own personal protection equipment (PPE), including safety glasses and steel-toe boots. Tools will be provided. Competitors are also allowed to prequalify personal tools during orientation. Competitors may wear a t-shirt, polo-type shirt, or collared shirt with or without their company or sponsor's logo(s). Material considered offensive is not acceptable and will result in competitor point deduction or removal from the competition. Casual slacks or well-kept jeans are permitted. **Each competitor is required to attend the orientation on Monday, 29 January 2024.**

Rules and regulations are subject to change by BICSI at any time.

EVENT E	Cable Troubleshooting / OTDR	30 min / 15 min	Various scenarios; Customer service, Speaking skills, OTDR
EVENT F	Fiber Link Testing	45 min	Test a fiber link
EVENT G	Professionalism / Orientation	60 min	Score based on resume, orientation (attendance and promptness), attitude, safety, use of tools and equipment, attention to detail, and aesthetics; Safety orientation
EVENT H	Competency Exam	60 min	50 multiple choice questions based on <i>Information Technology Systems Installation Methods Manual (ITSIMM)</i> , 8th edition
